## **BOONE COUNTY FIRE PROTECTION DISTRICT November 16, 2022**

Fire Chief Olsen stated he had spoken with Commissioner Aldred regarding Joint Communications and the Training Center property.

Fire Chief Olsen stated that with the SEMA Funding that was received for the 2023 fiscal year we were budgeted for an F550 and two Sprinter Passenger Van. A motion was made by Board Member Ritchie to authorize the purchase of a Ford F550 in amount not to exceed \$70,914.00 on Purchase Order 2022-1246. This purchase is utilizing the State Bid. There are only two manufacturers of sprinter passenger vans. Those manufacturers are Mercedes-Benz and Ford. Ford has provided us with documentation that they are unable to accommodate the request.
