Chief Olsen stated the Governor still has not signed the budget or our legislation that passed. Assistant Chief Leake stated the Governor has until August 28, 2023 to sign the budget.

Bureau Director Blomenkamp updated the board on the apparatus purchases. Two of our engines are in St. Louis. Staff will be going up Monday to go through them to finalize. T605 will be going into service on Friday evening and T805 will be going into service at the end of next week or the beginning of July. T505 will be the last of the tankers to get put into service. The DSAR vehicles are nearing service.

Bureau Director Blomenkamp stated that the Station 8 sewer pre-bid meeting is tomorrow at Station 8. Next Thursday is the bid opening. He discussed the Architect at Risk RFQ template and provided that to Attorney Parshall. Attorney Parshall stated that he would have something back in the near future. We will also be completing a Construction Manager at Risk in the near future. These RFQs will be coming to the Board for approval in the next month or two. Chief Olsen stated that there has been interest in leasing or selling Station 8.

Chief Olsen stated that the County has the appraisals; however, they have not reviewed them.

Chief Olsen updated the board on a meeting with Kip Kendrick with regards to Joint Communications.

Chief Olsen stated that Moody's would be doing our bond rating in the next week or two. The sell will be held on July 19, 2023, at 10:00 AM and approved during the July 19, 2023, board meeting.

Bureau Director Blomenkamp stated that the thermal imaging cameras and the extrication tools are in and will be delivered on Friday, June 23, 2023.

Bureau Director Schnieders stated that staff would like to change the procurement policy to better reflect the processes that we currently follow in order to procure items over \$10,000. Bureau Director Schnieders referred the board to the procurement policy in their packet. Board Member Watkins made a motion to accept the procurement policy changes as presented.
